

Ansteorra LoI dated 2011-11-15

Unto Gabriel Laurel, Juliana Pelican, Emma Wreath, and the rest of the College of Arms, does Eirik Halfdanarson, Bordure Herald, send greetings.

It is the intent of the College of Heraldry of Ansteorra to register the following items. Unless otherwise noted, the submitter has no desire for authenticity and allows any changes.

1: Daniel de Lincoln - New Heraldic Title

OSCAR finds the name registered exactly as it appears in March of 1992, via the Middle.

Troll Herald Extraordinary

This submission is to be associated with *Daniel de Lincoln*
Submitter has no desire as to gender.
Spelling ("Troll Duh.") most important.

Documentation Provided:

<**Troll**> Einar Ekblom, *The Place-Names of Wiltshire, Their Origin and History, Inaugural Dissertation, Uppsala, 1917, p. 163, s.n. "Trowle (Common) near Trowbridge"*, attests the place-name "Troll" in England in that spelling in 1349, 1372, and 1414. "The origin of this name is not clear."

RfS III.2 says that place-names may be used as heraldic titles.

(The Cover Letter of the March 2004 LoAR has "award unto Mari, Zenobia, and Daniel, the rank of Herald Extraordinary". While it doesn't provide a surname to identify which Daniel it is, the fifth paragraph up thanks Mari Elspeth nic Bryan, Zenobia Naphtali, and Daniel de Lincoln, and Zenobia Naphtali made a similar inference to support her registration of Black Stag H.E. on the June 2005 LoAR.

2: Daniel de Lincoln - New Blanket Permission to Conflict

OSCAR finds the name registered exactly as it appears in March of 1992, via the Middle.

The submitter provides the following letter:

"I, <submitter's legal name>, known in the SCA as Daniel De Lincoln, waive the full protection of my registered name "Troll Herald Extraordinary". I grant permission to

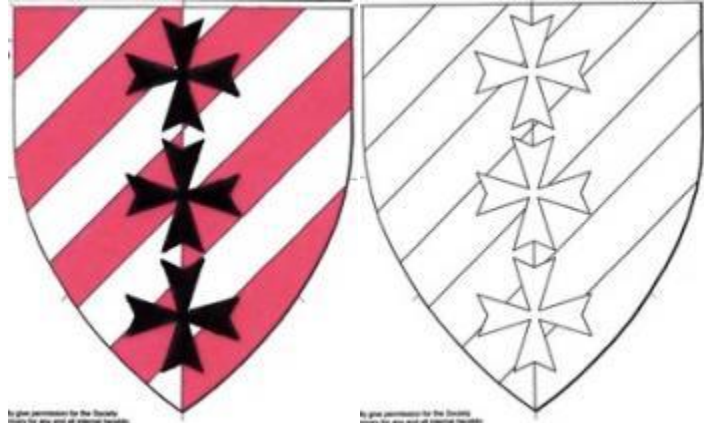

any future submitter to register a name that is not identical to my registered name (or even identical, if ever Laurel were to allow it). I understand that this permission can be withdrawn by written notice to the Laurel Sovereign of Arms, but that conflicting items registered while it is in force will remain registered."

3: Erich Johann Alberichssohn -
New Device

OSCAR is unable to find the name,
either registered or submitted.

*Per pale bendy sinister gules and
argent and bendy sinister argent and
gules, in pale three Maltese crosses
sable.*

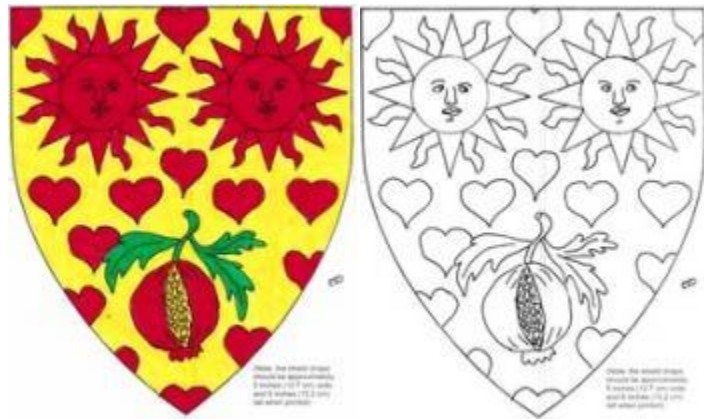


Submitter's name was registered in the September 2011 LoAR.

4: Pukhta Lovtsevich - New Device
Change

OSCAR finds the name registered
exactly as it appears in September of
2009, via Ansteorra.

*Or, semy of hearts, two suns in their
splendour gules, and a pomegranate
inverted gules slipped and leaved vert seeded Or.*



Old Item: *Or semy of hearts, two pomegranates and a sun in its splendor gules.*, to be retained.

If registered, this submission will be the submitter's primary device. His currently registered device, see <Swetelove Twyssoday> elsewhere in this letter, will be retained as a badge.

In Kingdom commentary, a commenter mentioned that the suns and pomegranate resemble female body parts. However, a majority of commenters stated they did not

see the submission that way until it was mentioned. In the decision meeting, the audience was split as to whether this violated RfS VII.1 Vulgar armory. We are sending this to the CoA for a decision.

Also, in the decision meeting, one of the audience members mentioned that the pomegranate was difficult to identify when viewing the form at a distance. When the device was projected through a document camera, there was no problem with identifying the pomegranate. This was not brought up in commentary and is mentioned as a possible issue.

5: Pukhta Lovtsevich - New Other

OSCAR finds the name registered exactly as it appears in September of 2009, via Ansteorra.

Swetelove Twyssoday

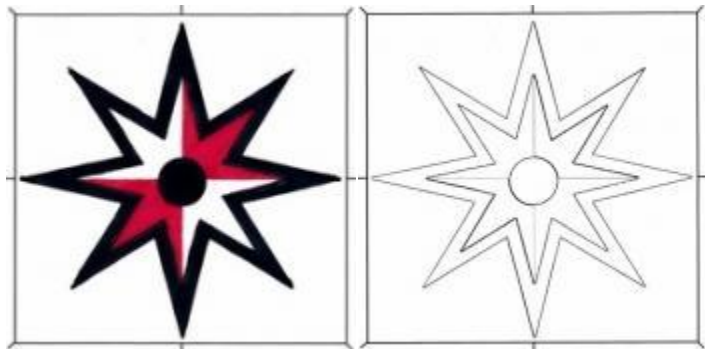
This is an administrative change of name designation.

<**Swetelove Twyssoday**> was registered as a New Name in the April 2010 LoAR. The submitter also has registered <**Pukhta Lovtsevich**> in the September 2009 LoAR. <Swetelove Twyssoday> should have been registered as an Alternate Name and the submitter wishes this to be changed to an Alternate Name.

6: Þorkell ǫlfúss - New Badge

OSCAR finds the name on the Ansteorra LoI of July 30, 2011 as submitted.

(Fieldless) On a mullet of eight points sable a mullet of eight points quarterly argent and gules pierced.



In the decision meeting, there was discussion of this being a pellet on a mullet on a mullet on a fieldless layer. The submitter's device was on the July 30, 2011 Ansteorran LoI and has mullets of eight points pierced. We believe that this is intended as a mullet of eight points pierced and does not violate the layer limit.

Also, this was blazoned as a rowel of eight points when submitted, but the CoH was not clear if a rowel could have more than 6 points. We reblazoned this to a mullet of

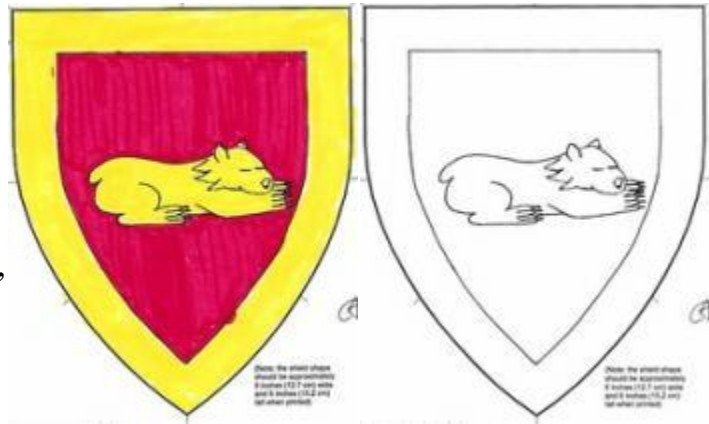

eight points pierced and leave to the CoA to debate the merit of rowels having a number of points other than six.

7: Uillecc Dubh mac Uilicc - New Device

OSCAR finds the name registered exactly as it appears in April of 2009, via Ansteorra.

Gules, a bear dormant to sinister within a bordure Or.
